**A fee for players transferring from selected nations in Europe to Denmark will be 100 € to the releasing federation, which means a total of 238 €. Otherwise the total fee will be 276 €. *No fee for amateur players to/from Greenland.*

***If the player changes status within a period of 12 months after the release as a non-contract player, the club has to pay the difference corresponding to the fee of a contract player.*

Important:

A player changing from professional to amateur player, will until 12th months after expire of the contract, be considered as a professional player according to the transfer administration fee, that has to be paid.

All administration fees are applicable for players over 16 years who transfer inside the EHF/ Europe as well as for players at any age that transfer inside the IHF/rest of the world.
